Also our communication is dreadfully difficult. The only medium I currently trust is this mail source. The phone as I have mentioned is an obvious area for career crims to seek info particularly for counter surveillance.

I am currently by myself at 699 but have little time and indeed miss lunch to type this. I'm off to pick up my kid and take her to Monster house, then mum will take her to the Newmarket pools next door. I haven't got the time or the inclination to accompany her further as I am busy and just do not want to perpetuate our current impasse.

Look there are several big issues looming here and I am sailing through a bloody troubled straight.

Jm is now obviously a much larger figure potentially involved in multiple criminal pursuits than any to which I was aware.

You were correct in steering me to continue plying jl a much safer more transparent source than jm will ever be.

I saw jl outside a bar in Queen st last night being there from 10.50 to 11.45pm. approx. You called and I was daring enough to take it as I was really wanting to talk if nothing else to ensure I was safe and to relax with your own family for the weekend. It made an ass out of us as the coverage sucked, in Queen St and I am left walking around in circles and looking odd.

In any event my role is compromised a lot at present and I will be pulling back and doing what I was doing cleaning up the house and staying low key.

If jm is in actual fact a friend not a foe of G Camp. I may be in deeper trouble.

Jm is obviously not just wondrous of me but has placed moles to counter surveil me and this may need further confronting.

I dropped the builder Don back there to 132 12.30 Sund. I was surprised to see so many Polic watching. They know my vehicle? They do not approach me??

I am being watched by others non govt Commodore ANU588 opp 699 dusk Sat 19.30 Three large Maori heavily tattooed faces etc 2 male 1 female gang types.

There are marked cars watching jm and he knows for the last several months and they watch and know the builder.



I do not want to be so painted?? I've young girls here in NZ and have historically continually been well known on and off any record for being opposed to dealing drugs, and or opposed to drug dealers being my particular bag.

At the end of the day if this is or has the potential to be a politically opposed challenge to current or any government in NZ, or is seditious behaviour period, or some form of subversive movement based as another highly charged radical group of disgruntled Maori (using their contacts with pakeha and other ethnics or non maori and all of whom jm & jl included are ultimately one by one or if timely all become expendable) then within the pursuit of your operational objectives a goal must include discovery of defined theme agenda's or motive I guess in detective speech.

It is all embarrassing and a mess I need to clean up, only can it be done slowly but it will start by Xmas.
